

“THE SPECIAL CONCERNS RESPONSE PROGRAM”

From time to time the Lincolnshire Police Department is called upon to assist with or respond to situations involving persons with special needs, such as mental illness, autism, epilepsy, Alzheimer’s disease, or other types of dementia. While some of our personnel have training in these areas, it would be a tremendous asset for us to know about a special situation before we arrive so we can send the appropriately trained people and to make sure we have enough help to deal with the situation so no one is injured.

The Village of Lincolnshire is lucky in the fact that one of our own residents, Pat Rodbro, is highly versed in dealing with folks in this are and has an extensive background in dealing with people who have special concerns. Pat is currently the Co-President of NAMI-CCNS (National Alliance of Mental Illness-Cook County North Suburban) and has unselfishly offered all of her help or that of NAMI.

Pat came up with the idea of creating the “Special Concerns Response Program” for Law Enforcement whereby the Police Department would maintain a highly confidential information program detailing the background and contact information of those residents with these special concerns. Pat has worked the last couple of years with staff developing the program and the enclosed information form. The information contained in this form will be entered into the Police Department’s Computerized Dispatch System so if we are dispatched to a particular address or are in contact with someone who is registered, we will have vital information at hand.

This program is a win/win for all those involved and will help ensure that your loved one and family receive the most appropriate serve we can provide.
